# Preface

This report compiles the raw data gathered from an informal online survey conducted in Riverdale Park in July 2006 to gauge community attitudes and about and impressions of Riverdale Park's town center.

The survey was open to all interested Riverdale Park residents and visitors and was intended to gather input, rather than to represent random sample of Riverdale Park residents or visitors, and the results therefore cannot be interpolated to represent their attitudes, opinions and characteristics. The Town of Riverdale Park publicized the survey's availability through newsletters ("The Town Crier", church bulletins, etc.) and distributed print versions of the survey at the farmers' market and on the MARC train.

Almost 300 people participated in the survey, a phenomenal response for a voluntary survey in a relatively small town, reflecting strong public interest in and concern for Riverside Park's town center.

Survey results will be incorporated into the retail market analysis and downtown business development strategy being crafted for Riverdale Park's town center in late 2006 and early 2007.

I have a fear that the empty stores would become a Radio Shack, a Quizno's and a Mattress Discounters, which already comprise 95% of the retail opportunities in PG County and would definitely NOT be desirable. I think we'll need to have community-oriented businesses because most people traveling up and down Route 1 don't even know Riverdale has a town center, so the stores won't be able to rely on through traffic. They'll rely on people who live here, or by word of mouth.

A baker/coffee/lunch/salads kind of place or a Thai/Indian/ethnic restaurant. I think a place like Firehook (bread, soup, sandwiches, coffee) could do well and serve as a regional post for their company in this part of DC. I would rather see a good independent co like FireHook or Spring Mill Bread Co. than an Atlanta Bread Company or some other fake-nice place that actually makes lousy bread and is just like 8 million Other potential would be a housewares/antiques sort of store like they other places. have in Del ray or Kensington, although I don't really spend money at those -mostly On the list of 'things not to do' --- the Little Giant on Route 1 is an iust browse. example of a new business that is just giving us more of the same stuff that we already have plenty of - lame atmosphere, plastic cutlery, and cheese steaks (and bad service, which is why it's not successful.) If restaurants and services are just not possible, maybe the area could attract architectural and renovation businesses capitalize on our area as one of the few parts of DC with a fair number of bungalows, Victorians - use it as a tool to market and showcase the area to the 'old house' renovators / urban renewers. That might spark something better later or have a

generally positive ripple effect. I would NOT like to see anything that signals poverty - no social services offices, at risk youth centers, free health clinics, etc. I recognize the value of these services, but they would completely kill any hopes of turning around the town center. I would also NOT like a business that is Spanishspeaking only. We have the 'Little Mexico' area on Kenilworth, which is very successful -- but I'd prefer we not to expand the strategy into Town Center. I am fine with restaurants that serve a diverse crowd -- but if you go to Tres Reyes or some other restaurants on Kenilworth and try to speak English, you literally can't communicate - it is a Spanish-only experience that is uninviting to outsiders and attracts only adventurous gringos. If you take your mom from the Midwest to Tres Reyes, she finds it scary, bewildering, and off-putting.

# SURVEY COMMENTS: Please tell us one or two ideas for making Riverdale Park's town center a better, more vibrant district

I think outdoor seating at restaurants and even nice benches along the sidewalks, something to bring the community together where we can hang out. The connection between Rt.1 and the train station needs totally revamped. The sidewalks are in bad condition, trees hang down low, etc. Clean it up, ad flower pots and benches, etc. Improve the road condition for Queensbury Rd. and Lafayette Rd.

The vision should be a place that feels unique and that a family can spend some time---an afternoon or an evening. This means that there should be no chain stores allowed or it will feel just like any other strip mall in suburbia. A place with socially oriented non-chain stores would lead to seeing and chatting with neighbors and would be a fantastic addition to our community.

Maybe Riverdale Park Day could have two locations: the mansion for children-oriented activities and the Town Center with live music, beer, food and other activities that would draw citizens to the center. Second idea: use condemnation to seize the properties from Doug Jamal and find buyers willing to actually occupy the store fronts.

Shops!! A sign off of Route 1 that would attract people to the Town Center, like the brown 'Historic District' signs. I often am attracted to these signs and seek out these areas when traveling. Banners off of Route 1 that advertise special days like a 'Riverdale Park day' - see Greenbelt community for example, they often have banners displayed across Crescent Rd that attract folks into the town center.

The foundation is definitely there. As mentioned before, the facades of the newly renovated buildings are lovely. Looking around Riverdale Park one sees a lot of people investing in their homes, but some people need help. To help people with 'curb appeal,' we may want to start a grant for people to paint their houses, landscape and replace fencing (the no chain link fences in front yard should be enforced - it isn't). Perhaps a certain percentage of tax money could be designated, or we could start a fund. Labor may be supplied by local residents or schools. To attract people to the town center before it is completely reborn (and after) we might want to have concerts there (instead of only at Riversdale), cook outs, and movies outside. Most importantly, bring in the business!!!

Create a useful, interesting and appealing area for people to shop, eat, entertain and interact with others in the community. Create a town center that is classy but has a small-town feel. Perhaps go for an architectural design that has a retro/Main St. look but is new and exciting. The vacant buildings next to the railroad tracks are a sorry sight - every time I drive past it and I just shake my head. They need to be torn down completely (the buildings, while partially-restored, do not look aesthetically pleasing). Some of the abandoned houses behind them could also be purchased and torn down to increase the amount of space needed for a REAL town center. Anything planned for Route 1 should be handled with care. The road is already a traffic nightmare, and anything built along it should have easy access in-and-out. All of the current buildings along Route 1 is a mis-match of random designs and styles. It would be nice to have a unified look for everything built from here on out. And let's not forget about parking. There needs to be a reasonable amount of parking spaces (if you think people will walk to and from the town center, you are kidding yourself). There also needs to be a well-planned traffic pattern to direct cars in and out of the town center. And while the buildings in the town center should be nice, the area AROUND the town center should be equally-appealing. The look and feel of the town center should expand into the rest of the community, with nice buildings, benches, banners, roads, curbs and sidewalks.

Free movies or performances in the little park near the center.

I think that by bringing certain types of stores it will help the center. I really enjoy Silver Spring's town center and I think a small scale of that would be great for Riverdale Park

A combination of pedestrian sitting areas with shades and fountains, and historic markers around the town telling about the towns history and experience.

I don't have a clue about how to get businesses that don't want to be here to move in. Needs a new owner who is willing to accept more modest rents to accommodate community-based businesses (national chains will never locate so far off the beaten track, anyway). Also, with College Park and Hyattsville having developed or in the process of developing the trolley trail, connect the trails through the Town Center to create a pedestrian/bike access that would help bring people to the types of neighborhood businesses that might thrive there.

increase advertising for the farmer's market renovate the bookshop building

My basic beliefs are that you must Include a variety of stores and businesses that are open a broad range of hours to make any town center a viable, vibrant area. Include ideas/ businesses that appeal to the public on a variety of levels, both convenience shopping [food markets, book store, etc.] and cultural endeavors [arts organizations, independent movie theaters, open mic night at a coffee place, etc.] to appeal to people in a variety of ways. Try to get people to stay in town, not just drive through or stop quickly, but a place that people can identify as a great place to find a number of activities.

Providing that enough advertising is done to guarantee noticeability, hairs/nails, jewelry (where is the security though!), fresh food market in the larger space, offices, print shop, boutique for antiques that are marketable to the period of most houses. Where's the Coffee shop!! or a Starbucks, (that would bring in customer traffic), Herbs, teas, and eclectic merchandise (YES)

1.better sidewalks with space between road and sidewalk, especially on rt 1

Take out a contract on Douglas Jemal. Or could we find some incriminating photos of him for blackmail? Sigh, somehow I don't think he'd care. Meanwhile, could we have a Saturday flea market? or do something like the farmer's market more than once a week? Especially Saturday and Sunday. Anything to bring people there. Live music in the summer? A little train museum? A fountain for kids to play in? Make it a destination, and businesses will follow.

Anchor the vision of the town center in quality, while being open to the many possibilities of development.

get the community involved. this survey is a wonderful idea. it may be helpful to publish it in the town crier so that EVERY Riverdalian has the opportunity to fill it out! advertising, billboard on e/w high flowers around all trees keep gardening up

Having a place where people can gather/meet others in the town.

Return the Riverdale Bookshop. Force Jamal to complete all renovations and constructions and rent or sell spaces at reasonable rates to small businesses.

During my travels through the town center I noticed that some of the streets need improving. Some of the older shops could use a face lift.

First of all, find out the truth..does the town have any leverage here to bring the developer to come to the table and say what his attentions are. If there is no chance of the town getting these properties developed thru him, What actions (of any) are available to the town? Why make plans for something that cannot happen?

develop a better working relationship with the developer; stop being a business-unfriendly government

Make the train crossing a four-way crossing to quite the whistles a bit. Figure out how to control the traffic at that intersection a little better. (4-Way Stop signs so people would wait a little for the people on Lafayette to make their turns, etc.) See #3 for the types of businesses that would make for a more vibrant district.

Find someone with connections to Jamal and ask him what it would take.

1. Traffic restrictions on Queensbury Road to make Town Center more pedestrian friendly. 2. More community events that take place at the Town Center, as opposed to the Mansion.

Connect trail with R.I. Ave trail in College Park and Hyattsville to Bladensburg Riverfront Park. Add a bakery with small eat in option.

None at present time, since the property owners have no interest in dialog.

Rethink and relax MUTC. MUTC Committee and Town Council need to expect to say 'Yes!' to developers unless a project is proven unworkable; the default today is clearly to shout 'No!'. (Are you reading, Kiernan?) This town needs to reach a critical

mass of people in order to support local shops, since today, residents are clearly used to traveling out of town to obtain goods & services. Projects such as the proposed condo/retail building on Lafayette and Queensbury need to be encouraged, not thrown out on technicalities, because Riverdale Park clearly needs to bring in that density of people. That developer understands that two stories of residents above one story of retail does not bring in enough people to support the retail. Maybe in a bygone era, when transportation was much more arduous, that type of a building worked, but today, it clearly doesn't. So relax the MUTC process, and let Patriot build the condo/retail complex by the train station. That will jumpstart the entirety of the town center, making the rents in the existing storefronts cost-effective again.

Re-Build the whole place. I hate to repeat myself but all you have are a few tired, old looking buildings, that includes all the buildings along Route One, except the former Citizens Bank Building. It's just not very appealing to anyone. Sell it and let a 'real' developer develop it, no more 'Greek' slum lords. The Route One Queensbury road area has to be re-done, sidewalks, lighting, etc

Increase business in the Farmers market as a means to get people used to coming there. Hold other public events there, such as a flea market, an arts festival, etc.

Mixed Use is good. Exhibits or small museum on Riverdale History.

In addition to what I mentioned in # 2, it would be great if the space under the MD Route 410 bridge could be made 'friendlier'. I live north of 410 and east of Route 1 so I get to the town center by walking on a dark and somewhat creepy sidewalk, down a flight of stairs, and under the bridge. More lights would be helpful, especially along the sidewalk. It would encourage people in that whole 'quadrant' of Riverdale to visit the town center more often.

We should leverage the success of the existing Farmer's Market in whatever way we can. Maybe you should conduct a survey to document the foot traffic and value of

weekly sales during July and August at the farmers market. If you have a methodology for doing it, we can assign the market coordinator to carry it out for you. (Assuming you think that data would be valuable to econ dev efforts) Likewise, is there any way we can capitalize on the train watchers or interest in trains? This is probably too narrow a group, but it is the only other sign of street life in town center. How about open houses or tours that are regularly scheduled, aggressively marketed, and geared to showcasing town center and the general area? You could market it to developers, retailers, and commercial leasing agents; hold it on summer Thursdays when the Farmer's Market operates, give them some wine and cheese and try to sell them on how great the area is. I think that a lot of business people still make decisions based on gut instinct and observation -- if they SEE that there are a bunch of yuppies buying expensive bread and flowers in PG County, it changes their perception of the area. (even if it's a relatively small number of people) Attention to appearance and details. The town has done a poor job of maintaining our gardens and pocket parks so I doubt they could manage to do this for town center. But, sprucing it up with NONWEEDY planters, bright flowers, clean sidewalks would help its appeal. ENFORCEMENT OF RULES would also help. Douglas Development has had a piece of plywood in one of the door transoms since the previous town mayor, so that is at least 1 year, possibly two years that have gone by. (I have asked every ward rep to no avail to please get them to put glass back in the window) Right now the church is disposing of all its garbage in the trash receptacles, so the trashcans are overflowing with trash, with piles of trash surrounding the cans every weekend (which is a code violation, that never seems to get enforced.) The church should not get away with disposing of its trash improperly just because they are a church or because they speak Spanish and no one on the town staff can communicate properly with them. Besides that, I thought that leasing to a storefront church was no longer an allowable use in the town center? rationalize traffic flow. keep cars slow, maybe divert through traffic, clarify right-ofway at offset stops.

It is too out-of-the-way to attract drive-by traffic. So, I think the only type of business that would survive is a business which you already know about and are willing to drive to. (such as restaurants). We also need many more choices in cultural events. Other than Clarice Performing Arts Center, this general area is a cultural wasteland. Why not have a high-end Jazz club? (by 'high-end' I mean a place that will attract older people who want to listen to music, and are okay with paying a little more for it) -- Maybe something like 'Blues Alley' in DC. Or a small movie theatre that shows specialty films? Old Greenbelt theatre does this to some extent. But, what about a small movie theatre that has something different -- such as baked goods instead of only popcorn. And showing highly selective films -- There is a theatre in Albany NY that I am thinking of --it is called the Spectrum. very successful. It has found its niche. maybe take a look at their marketing strategy. Overall, I think that it would be good to get more information from people in University Park. Most of us need to drive way out of town for entertainment -- but we would RATHER spend money right here in our own neighborhood! So, I would do more surveying in UP, and I'd consider business to attract a crowd that is a bit older, highly educated, fewer children, and with a bit more money to spend. Personally, I leave town to eat at nice restaurants, to find some live music, to shop at a good grocery store with lots of choices, and to see a good movie.

Get some stores in there! Recreate a great small venue for live music that is inexpensive & family friendly

better signage leading people there -- it's hidden from the main roads and you don't know it's there till you're in the middle of it

Bring in 1 or 2 businesses that draw traffic to others

Get something in there

Advertise changes/events/openings on the listserve; make it pedestrian/bicyclists' friendly.

I would like the Riverdale Coffee Shop to return!

We should study what other small towns have done to revitalize their business districts. Maybe offer tax incentives or seed money on easy terms for LOCAL entrepreneurs.

A good restaurant will bring people in -- talk to Mandalay?

With the current renovation of Rt 1 as a commercial and arts district, I would prefer to see the businesses remain in that area, and keep Riverdale Park residential.

get a bike/pedestrian path along right of way from college park to here fill the stores!!

A community bulletin board, open-air but sheltered. Many communities have these and it's an inexpensive way to advertise and find out what's happening. A bike path to join up with the new bike path from College Park. Well lit and occasionally patrolled by police on bikes to keep it safe. Bus transportation from Riverdale to Greenbelt. There's no way to get there directly by public transportation without taking the Metro and about two hours (for 5 miles!).

# BUSINESS

Keep the Farmers' Market going; offer up something like Hyattsville's Family night or summer concerts (or more things like the rides to see the lights at Christmas) so that folks can see what a charming town Riverdale is. Get in some useful businesses in the center so that it doesn't look like a depressed ghost town.

Work with the owner of the property to promote occupancy of the buildings.

Get tenants for vacant buildings that encourage a lively walking and shopping area;

Activities that draw families in the evenings. Maybe you can do something like the Hyattsville Summer Jam (except on a different night, of course).

Get businesses in. Not low-rent dollar stores, but something nice.

We need independent, locally owned businesses that are committed in the community and economically and culturally grounded here. These are the kinds of businesses that would not only meet shopping and dining needs but ideally could foster a sense of local community in new ways.

Have a cafe area. Perhaps live music once and a while.

I've heard the rents in the town center are high. Are there any federal, state, or county grants available to the town or to businesses that could offset the high rents? Can you approach the P.G. Chamber of Commerce?

A walking trail or park near by so that you go do a little shopping or looking and then, stroll through a park.

As mentioned earlier, bring in small independent shops to provide services for our community. Food would be most welcome. Not a hair place, or mobile phone stores, or chain stores, please!!! Bring us something that we can't get by driving to the next town over, or the next state over. Please develop to encourage walking into and using the town center, rather than driving and parking.

With the many buildings that are present (and continue to grow) on River Road, there is a vast lunch crowd always looking for places close by to spend their lunch hour (and money!). Riverdale Town Center is in a perfect location to attract these patrons. Besides adding some of the business I mentioned above, here are a few other ideas that would draw me there often: 1. Focus on Riverdale's rich history and contributions to Maryland's conception...and then flaunt it! Perhaps by using names from history for business, or for lunch specials, or decorative but tasteful banners. 2. Add some nice hanging baskets of flowers. 3. More benches (in the shade and

sun so in the summer there's a cool place to linger and in fall/spring, a warm place to linger). 4. Revitalize any run-down buildings. 5. Put some focus on the train station because it is part of the quaintness of the town.

Closing off car traffic at least one night a week, providing parking elsewhere, opening up the area for free performances and late-night shopping.

Bright signs, lights, definitely food. A cute indoor/outdoor cafe would be nice. Since there are many Latino in the area, perhaps a chic place that offers Hispanic foods would be nice. Put emphasis on the word 'chic'. You want to be careful to maintain the sense of class and good taste the town center has.

1. Continue to build up the farmer's market crowd. 2. Allow local, innovative establishments to move in and take the big risk of starting a business through grants or initial aid from the town. 3. Get on the ball and continue the bike trail that runs along the old trolley line/train tracks. Berwyn Heights and College Park have invested in a paved trail, and people regularly bike, rollerblade, walk, or run through their towns because of it. If we would pave and light our portion of the path (which is dangerously overgrown most of the year), the town center could be a destination for all of those people that use the trails. Wouldn't that make our new cafe happy? user-friendly parking behind the Calvert House Inn/vet - the big curb you have to drive up is a little off-putting. encouraging bike riders to come - bike racks, shade trees, drinking fountains.

Throughout the summer, publicize and hold: -- evening music concerts featuring different age groups and styles of music with dancing; -- arts and crafts fairs -- sports/games contests: bicycling with children, remote control demos including miniature airplane, cars, trains, etc.;

The park at the town center needs a fence to separate it from the traffic on 410. Also, city/county engineers could be consulted on other possible traffic calming measures for the MARC station area. More publicity for the town to attract businesses - like the article in the Post on 7/8. Provide/Better publicize specific volunteer opportunities to improve town center.

more events going on...musical performances? More things to get people to stick around after they get off the train, or come down, frequent the businesses, and spend their money.

Lease up the vacant stores; make Jemal do something constructive with the book store he closed.

Work with MARC to increase the availability of trains to and from the Riverdale station. Increase traffic calming measures to limit traffic to local only and decrease speed. Increase street lighting to add a feeling of security at night.

An unrealistic desire to take the property away from the Jemal brothers and give it to someone with vision and deep pockets. This area is never going to turn around while the Jemals keep that property at such a ridiculous per square foot price. I'm sure it's just another write off for them.

Create a sense of place. There area does not have an image, despite the big clock - it still reads like a parking lot. Increase the density. Tear down the McConky/Heincke Building. In the interim, do something at the town center that creates activity, such as a childcare center so that people have to come there. Make it visible from 410. Use light and color - take a look at Franklin's Restaurant, including its sign and the view of the brewery through the windows.

Farmer's Market Parking in the lot across the tracks if allowed should be marked 'Additional Market Parking'.

Tear down the small 'old buildings'. 1920 has come and gone. Expand to the northern side of E-W Hwy. Get rid of the towing company. Start from scratch, build up and expand the train station. Look at what they did with the old hardware store in Hyattsville. When an area looks old and dumpy(Rt 1 and Town Center ), the people you are trying to attract will just avoid it. Get the vet on Rt 1 to move to the Town Center and then you could tear down everything else along Rt. 1.

If you could bring an anchor store like a Whole Food's market which we do not have in P.G. county--that would really help. I think a MOM's organic market might also do the trick. This may sound obnoxious but a starbucks might also bring people in. Also it is a very historic area, you could bring tourists here if Riversdale mansion had better funding and staff, you could have historic walking tours or bus rides, maybe even something in conjunction with the free boat ride on the Anacostia that leaves from the Bladensburg harbor which is wonderful and the dueling grounds near there. This entire area is very historic and the University of Maryland special collections library might be able to help with information to develop a walking tour. Tying into arts district somehow might also be a good idea.

Obviously, getting anything in the town center would be a start. I would suggest holding art and music festivals, athletic events such as a 5 or 10 K run. If we get a couple more restaurants, particularly those that have live music, it could help build a nightlife. The town center also should not shut down at 5:00, if we are to have a vibrant district we must have a nightlife.

Open businesses, hold community events there.

The area needs to attract more people. The vacant stores turn people away.

Bring commerce, a bank, bring a brand name-popular coffee shop like Starbuck's for an immediate image jolt (!), bring food, nice fast food or moderate priced attractive restaurants, bring in the Riverdale history with the Anacostia, and the railroad..Keep the wonderful open air market on Thursdays. Have cultural events like 'Riverdale Day' every year, and have events for children, events for families. Have a weekly or monthly flea market like the ones in Georgetown and other places. People love them. Have a friendly police visibility. One or two riding on bikes. Have a kooky contest. Have a coffee shop that has musicians play. Have musicians play outdoors...Musicians love to play, and people love them around.

I really think that there need to be businesses in the space by the MARC station.

Well, if the 'town center' is to be both the area by the MARC train station and Route1, there has to be some sort of visual or human connection between them (similar architectural styles or signage; landscaping or pathways that join them (I mean this more in a psychological sense as they are already physically joined by both street and sidewalk). I tend to think of the town center as 90% empty or unfinished, so making it more vibrant means filling it with tenants and getting people to go there. The farmer's market is a good example of something vibrant that goes on there. The Riverdale Bookstore used to be a great place to both shop and catch up with neighbors/friends--it also served as a kind of performance venue with free music on Saturday nights. S&J has been doing some of these outreach type of events--I think businesses and events that reach beyond just trying to make a profit build a real sense of community in

Riverdale Park. Prior to the businesses moving in to the town center, it would be wonderful to see it being used for more community events or rented out as a backdrop for movie filming.

Businesses that people return to frequently so there is lots of traffic--places to go for a cup of coffee, gifts for kid birthday parties, fun gifts for friends, place for a quick inexpensive BUT GOOD meal on a night when you don't want to cook

If Route 1 is to be an Arts District, we need shops that reflect such products...either supplies to create them or places to purchase art. A small gallery would be nice. Activities available such as music, art shows, flea markets, etc.

Have events there - performance art, free concerts, art exhibits, pet parades, etc. Also have more shops open late when you do have shops. S&J is great for what it is but there needs to be more. Have a bus, trolley or shuttle going from nearby places like Mt. Rainier, Queens Chapel & Hamilton, College Park, Peace Cross etc. to the town center.
