Code Corner

Newly placed under Town Code Chapter 50 "Peace and Good Order" of the Town code for the Town of Riverdale Park is: 50-15 "Outdoor Unenclosed Storage Prohibited." This code was introduced and added in an effort to work towards ensuring the health and safety of the residents of the Town of Riverdale Park. Town code 50-15 "Outdoor unenclosed storage prohibited" prohibits the storage of such items as: paper products; building supplies and materials; flammable materials; motor vehicle parts; appliances; and household furnishings on any unenclosed porch, deck, patio, carport, including any space that is not sealed from the elements and does not have properly fitted closeable doors. Conduct your own inspection on your porch and/or under your carport, you might be amazed at what you find. If you have any questions/concerns call the code division we can help. The Code Enforcement Department will be strictly enforcing Town Code 50-15 commencing the month of November. Violations will be subject to a fine.

During the past month the Code Enforcement Division has been actively enforcing the Town Codes, Mobile Vendors Licensing, Apartment Inspections, Single Family Rental Inspections, and enforcing Town Parking during school dismissal on Queensbury, Riverdale, and Taylor Roads. The Mayor's Report

Infrastructure program

When running for office in the Spring of 2005, I set as one of my two priorities bringing all existing town streets, sidewalks, and other infrastructure up to County standards. I want to catch you up on where we are in the process of making the promise become a reality.

When I took office a year ago there were already several small street projects underway or planned. The projects in West Riverdale, along Spring Lane, Queensbury Avenue and on 48th Street have already been completed. The 4700-5000 blocks of Somerset and Sheridan project is underway, and will be completed prior to the end of this construction season.



While moving these projects forward, I used town staff and the town engineer to identify which streets need improvement so that we can both estimate the cost and know which areas to include when we ask construction firms to bid on the work. You may also recall that I've made several requests through the Town Crier, the Town Talk e-mail list, and at public meetings for residents to inform us of infrastructure problems to make sure we don't overlook them. I presented a preliminary report to the Council in the spring that estimated the cost of the needed work at \$3 million, and the Council provided funding for the work in the budget that took effect on July 1, 2006.

We are now in the process of seeking bids for the engineering and construction work. The bids should be in and the contracts awarded to the winning firms by the first of year. Because there is so much work to be done, the work will likely be done in two separate phases. We will publish the work schedule in an upcoming issue of the Town Crier. Phase one will likely begin with concrete work next March. Residents of effected streets will be notified immediately prior to the commencement of work. It is my hope that all of the work will be completed no later than the end of 2008.

Community Center

You will note on the first page of the Crier that a public forum regarding a community center will take place on November 15, 2006 from 7-9 pm at Town Hall. If you are interested in making your voice heard about issues such as what services and facilities should be made available in Town, and where they should be located, please join us.

Immigrant Task Force

Among the critical issues facing our town today are those revolving around new immigrants. I want to emphasize that there is great diversity of immigrant situations and issues which include housing and labor markets, concerns about language, communication, social integration, and economic development. What seems clear to me is that the Town residents and government must be more active in helping to smooth the transition of immigrants into American society. We have included Spanish translation for part of the Crier, and all of the recently published Residential and Business Code Handbook, and made it a priority to hire town staff (both civilian and police officers) that is fluent in Spanish. But, there is much more we need to do to guarantee that our town remains a thriving middle-class community. Working with our immigrant population will help make this a reality for all of us.

Town government, as it currently exists, is not very well structured to grapple with a rapidly-evolving immigrant population and the issues they confront; it is really only structured to react to problems long after they arise. One means of helping the town move forward on assisting immigrants is to carefully study what issues the community and immigrants are facing and to find answers to the problems we confront. In order to do this, I am going to ask stakeholders to participate in a task force that will address issues related to immigration in our community. This group will have meetings early in the New Year. If you are interested in these issues please watch for postings on the community calendar.

Traffic on Highway 1 and Route 410

The Town recently learned that there are several new opportunities available to improve traffic flow through the intersection of Route 410 and Highway 1. The large redevelopment project of the former Lustine properties in Hyattsville, and stretching into Riverdale Park along Madison Street, will require traffic mitigation at the intersection in order to gain county approval. This will at best demand an incremental improvement of traffic flow, but some improvement will certainly be welcome.

Another upcoming improvement will come with the synchronization of lights along Route 1. The new lights that have been constructed from the boundaries of the District of Columbia through to College Park will soon be synchronized in a way that facilitates the traffic flow for the whole length of the highway. This should help the backups that happen around the intersection of Highway 1 and Queensbury Road and hopefully reduce the cut through traffic that occurs along Cleveland, Oliver, and Riverdale Road. After years of no real movement about this issue, it appears that things are finally happening. Stay tuned for updates on a rapidly evolving situation. My best wishes to you and your families for a Happy Thanksgiving.



Riverdale Park Municipal Tax Relief

from the County

In 1983 a municipal tax differential program was established pursuant to Section 6-305 of the Tax property Article of the Annotated Code of Maryland.

The purpose for the program is to eliminate double taxation and provide a property tax differential credit for municipal services that a town provides i.e. general government, police, public works, etc.

The Tax Differential is a process for determining the appropriate property tax rates for residents of municipalities within Prince George's County.

Residents see a reduction in the county government portion of the property tax bill to account for services that are provided instead by the municipal government.

To qualify, the municipality must provide a service that replaces a service that is currently being provided by the County. Therefore, any service provided by a municipality that is not funded in the Countie's budget or General Fund is not eligible for a tax differential credit. In addition to the criteria outline above, the municipality must utilize some property tax revenues to pay for this service.

Since 1983 to fiscal year 2007 the tax differential program has <u>resulted in millions of dollars of municipal tax relief to real and personal property owners within the Town of Riverdale Park.</u>

Graph #1 illustrates a 20% increase of total Municipal Tax Relief Funds to the Town of Riverdale Park real and personal property owners' amounting from \$479,210 in fiscal year 2005 to \$601,727 in fiscal year 2007.

Table #1 illustrates our municipal tax differential ranking (credited rates) for similar services that municipalities provide. Our ranking for Riverdale Park Municipal Tax Relief and the level of services we provide is #3 in the county. This is our third consecutive year (fiscal year 2005-2007) at this ranking behind the City of Laurel #1 and City of Greenbelt #2.

The Credited rates for the municipal tax differential as shown highlighted in Table #1 for Riverdale Park are calculated and applied on the annual FY 2007 County/Municipal Property Tax Bills.

Public Works Report

Holiday Schedule

Public Works is closed on Veteran's Day, Friday, November 10, 2006. Bulk trash and metals pickup for Area A will be picked up on Wednesday, November 8, 2006 and for Area B on Thursday, November 9, 2006. Public Works is closed for Thanksgiving on November 23 and 24, 2006. Bulk trash and metal pickup for the whole Town will not be picked up Thanksgiving week per a Council action.

Leaves

Leaf collection will begin on October 30, 2006. Please do not park vehicles on the street in front of anyone's leaf piles as they cannot be collected. Residents shall rake leaves as close to the curb as possible for collection, but shall not rake leaves or deposit yard waste or other debris in the street or gutter. We ask residents to be patient; if you see the leaf machine has been on your block on any given day, it will be 3-5 working days before the leaf machine will be back to that block. We are trying to provide all residents the same service. It is this department's goal is to be on everyone's block at least once a week. During leaf collection season, bagged leaves will also be collected as yard waste and should be put out on your first collection day of each week

Recycled Paper

Public Works is open on Saturdays. Residents may bring their trash, metals, yard waste, and mixed paper for recycling. The same restrictions/rules apply on Saturdays that are in place on the week days. The **recycled paper** consists of card board (such as cereal boxes, shoe boxes, and boxes), junk mail, magazines, books, telephone books, etc. The Town receives revenue from recycling these items and it helps to lower the landfill costs.

Contacting Public Works during Emergencies

In extreme emergencies (e.g., snow storms, hurricanes, etc.), resident calls for Public Works need to be routed to the Police Department (301-927-4343) who will contact us. Often Public Works staff is not available to answer the phones, but the Police Department has radio communications with Public Works staff.

Emerald Ash Borer Quarantine Alert

Prince George's entire County is under quarantine because the Emerald Ash Borer has been found in southern PG County. All residents and businesses are being told **not** to move any firewood out of Prince George's County. Economic Development Update

A few notes from around town:

- EYA is working with Prince George's County and SHA to mitigate the effects of traffic associated with the first phase of their Hyattsville project. Based on traffic counts, the County and SHA are proposing that the right-only lanes east bound and west bound on 410 at Rt. 1 be changed to allow traffic to drive straight through the intersection. As part of the plan, 410 between Rt. 1 and East Beale Circle will be widened slightly. A drawing of the proposal is available at Town Hall. (Please also see the Mayor's Report where this is discussed more.)
- Mr. and Mrs. Shi, who own the Alamo Plaza, are looking to redevelop the vacant parcel with the abandoned house on Riverdale Rd. At the moment, they are considering commercial and office space with a stucco exterior similar to the Alamo Plaza.
- A small medical office building is being proposed for the southwest corner of the Kenilworth/410 intersection. The entrance to the building will be off of Powhaton St. Dr. Darden, a pediatrician, is interested in opening a pediatric practice in the area. The project is currently being reviewed by MNCPPC, but Council will have the opportunity to comment in the future.
- The Riversdale Mansion will have a new visitor's center in a few months. At the October Legislative Meeting, Ed Day presented details about the new center. The Center has been reviewed by the Prince George's Historic Commission as well as the Maryland Historic Trust.

- Kennedy Smith, our economic development consultant, is continuing her market analysis and interviews with residents and businesses. If you have any questions for her or suggestions, please email her at kennedy@cluegroup.com.
- The Wells Building, which houses the doll shop, is for sale in Town Center. The building once housed the Riverdale Park Post Office and still has its original tin ceiling.

Our Town A Tree Grows in Riverdale

It was the best of times, the 50's and the Queensbury Dukes reigned supreme in Riverdale. Their black leather, chrome studded jackets, and slicked-backed, pomaded hair let people know who they were; they were the Dukes and let no one doubt that they ruled the turf—the streets of Riverdale Park then just simply known as Riverdale.

Slaus, Roach, Hacker, and Mutt aka Stan, Billy, Martin, Leonard, and Roy Bremmerman, Dave Wolfe, and Ben Guiffré were members of the Dukes, but better than that, they were friends till the end. Through thick and thin, they weathered the trials of adolescence and found a way to rise through it all. That's not to say that their beginnings were easy. They were scrappers and no one tread lightly on their turf—the streets west of Route 1 and south of East West Highway, Queensbury and Riverdale Roads and the streets lying in between. They were an awesome bunch who most often intimidated those who they perceived to be intruders and bad guvs while protecting their neighbors, classmates, and teachers. Through all the bravado, there was an profound core of caring among them. They came to love life and its trappings, became aficionados of Beowulf, Ivanhoe, and Lord Byron, and grew to be kind, compassionate, and loving men. Ultimately, they became lovers of all things natural including trees—all trees and especially ones they began planting in remembrance of family, friends, and times gone by.

Roy was just one of the guys. He grew up to be a hero with a wife and child. And even though Roy, Dave, and Ben moved away, their hearts and minds were always one with Riverdale. Roy died this past year. He was 72 and had lived a good life. Two of the Dukes, Ben and Dave, met recently with Roy's widow and daughter to plant a tree—a Pin Oak that was planted in Beale Circle on October 13, 2006. They dedicated the Oak to Roy with a prayer..."Thank you Lord for lending us the soul of Roy Bremmerman. He brought us joy and we loved him well. It is for him we plant this tree in a place he loved, a place where elders come to sit in the sun, lovers stroll, and children play".

Unlike many trees, the native pin oak (Quercus palustris) likes clay soil and doesn't mind wet feet, two conditions not enjoyed by many other trees and a temperament admirably suited to Riverdale Park. Much like Roy, Ben, Dave and the rest of the Dukes, Roy's Pin Oak will thrive in Beale Circle in Riverdale Park and someday grow to 75 feet—a testament to all rough-hewn young men that became the best of men among us.

It is fitting that they choose Beale Circle to plant Roy's tree officially title "The Bremmerman Oak. Beale Circle was the Duke's headquarters where they met, played games, settled beefs, and shared dreams in the 50's. The Dukes returned in a new century to plant a tree in memory of a friend now gone. The Dukes leave us believing still in the caring, sharing, all American spirit. In short, that Riverdale Park is "TREEmendous"!


