# Ward and Committee Reports

## Ward One Report

### A Procedure for M-UTC Proposal Review

At the last legislative meeting, I introduced a resolution to establish a formal procedure for how the Town Council considers new developments in the Mixed-Use Town Center Zone (M-UTC). This may sound very technical, but I believe it is the most important thing we have done as a council this term. Previously, it was possible – and indeed did occur – that the council might undertake decisions on development without receiving or reviewing insightful and detailed technical reports produced by the M-UTC committee.

Our new policy was inspired by the way that the Prince George's County Planning Board makes decisions: the Council must receive the report of the technical review board (M-UTC) and discuss it in public session. This does not tie the Council's hands when it makes decisions, but it does ensure that the Council makes decisions will be discussed in the context of the M-UTC committee reports.

There are many processes in our town government that are traditional, but not actually formalized by any policy. I believe that it is critical, especially in an era where staff and elected officials may change frequently, to formalize the intent of government in written policies to guide our institutions. In short, I think we need to formalize policy on many things, and am working to do that in partnership with my fellow council members.

### A Deadline for Wachovia Development

The Council also accepted my proposal to add a one-year deadline for ground to be broken on the Wachovia project at the corner of East-West Highway and Route 1. If a year passes with no development activity, then the covenants the developer needs to move forward will automatically lapse. Should there be another year of delay in this project, I believe the town deserves the right to review this project and that we should be willing to say no.

### Other Economic Development News

Over the last month, I met with three property owners along Route 1 to discuss their ideas and proposals for future development. These plans are not very far along – and some of them may never happen – but it is good to know that although the housing market has cooled, the local stimulus of the EYA and M-Square projects are continuing to drive interest in further commercial development. To take advantage of developer interest, it is paramount that we stick to our

guns on our zoning. That is the message I consistently give to developers and property owners.

### Traffic

Thanks to Mary Donaldson and the Traffic Committee for an informative meeting this month with the traffic engineering firm The Traffic Group. I hope that this meeting will prompt the town to move forward with a full traffic study soon. The funds are already in the budget, and we are currently awaiting a proposed scope of work from a traffic consultant.

### Electronic Documents Update

At the last legislative meeting, the Council voted to create an Internet-accessible archive of all public documents created by the town. Implementation of this and other electronic documents policies is taking longer than expected. At the December legislative meeting, I will introduce a resolution creating a reference library of government documents in Town Hall for the enjoyment of all interested citizens. I also hope to create a separate reference packet for incoming council members.

### Spanish Language Outreach

One of my campaign promises was to improve Spanish-language outreach by the town. The Town has since hired an expert in this subject (Deputy Town Administrator Penelope Guzman), but I remain committed to creating policy guidance in this area. I plan to introduce legislation on the subject at the January legislative meeting. Those who are interested are welcome to call or email me with suggestions.

### Holiday Market and Festival of Lights

On Saturday, December 8 and Sunday, December 9, the Riverdale Park Holiday Market takes place in Town Center. This is a great holiday event created by great local volunteers. Excellent vendors will be present selling handmade jewelry, specialty gifts, Christmas trees, and more!

Remember to decorate your house with lights in time for the trolley tours on December 8th! We still need elves and reindeer to help host our trolleys and to assist with the children's holiday party on the 15th of December. If you wish to volunteer, please contact Anissa Sunday at (301)277-2458. I was a reindeer last year and it was tons of fun.

Finally, I send you all my best wishes for a warm and festive holiday season. As the holidays approach, I have been reflecting on how much I value the friendship of the neighbors who make Riverdale Park a special place to live. So many residents have helped me and entertained me over the years! I have come to know and respect many of you, and I can truly say that I consider it an honor to serve such wonderful families as I have met in Riverdale Park. I look forward to continuing that service in the New Year.

## Environmental Initiatives

Recently I had the opportunity to attend the Maryland Municipal League conference in Greenbelt, MD. The conference was a great forum to discover how other Maryland towns and cities deal with a variety of common issues. I found one session, "Going Green: How to make your City more Environmentally Friendly" to be especially helpful. The session presented a number of great ideas for small towns with limited budgets. I presented some of these ideas at the October meeting of our new Environmental Committee that Jonah Blaustein has founded. Jonah and the committee have arranged a presentation on the "Cool Cities" program that aims to spur local action to reduce global warming. I encourage everyone to attend or tune into the Legislative Meeting on Monday, December 3<sup>rd</sup> to watch this presentation. And if you are interested in making Riverdale Park more environmentally friendly, come on out to an Environmental Committee meeting!

## Police Department

This past month I participated in a police ride-along with our excellent Riverdale Park Police Department. I'd like to thank Officer Vitchock for hosting me on the Saturday evening shift. I was very impressed with the work that our officers perform. They have many different roles to play in a single evening, and keep their cool in many challenging situations. I was also happy to see the new laptop computers in the vehicles being put to great use. I continue to share the mayor's goal of adding more officers to our Police Department in the future.

## Route 1 Corridor

On November 15<sup>th</sup> 2007, I attended the forum on Route 1 Corridor growth sponsored by County Councilman Eric Olson. M-NCPPC, Prince George's County, and the Maryland State Highway Administration discussed the major plans guiding growth in our area. Many residents expressed concerns to the government officials present about school overcrowding and traffic congestion. I share these concerns with respect to proposed development within Riverdale Park's borders. I support economic development, but as plans progress, I will be asking developers to be more proactive on these important issues.

I hope everyone has a wonderful holiday season. Be sure to visit our Holiday Market and join in the Festival of Lights!

Even amidst all the streetscape work the trees along Taylor Road look beautiful. And speaking of pleasant drives...

Early in November The Traffic Group gave The Traffic Study Committee a presentation entitled Traffic Calming 101. The presentation covered various ways to reach equilibrium between motorists, bicyclists, pedestrians, and something we are seeing more and more of, playing children. The group offered to work with the Town on some of our most challenging areas. And speaking of mobility and access...

With the completion of the curb, gutter and sidewalk work along Taylor Road similar work will be coming to three streets east of Taylor: Nicholson, Oglethorpe and Riverside Drive. The Mayor and the Council have received comments in favor and opposition to this portion of the project from our neighbors. In 2000, the Council passed R-2000-5 creating the policy of installing sidewalks on at least one side of a street when repaving occurs. Mayor Archer stated in 2005 when running for Mayor that if elected he would bring our streets up to county standards.

A hearing was held to discuss this more in depth. I'd like to thank all of our neighbors who came out to the first hearing and making their opinion known. Those from the Town staff found the hearing constructive as did the Mayor and I. Especially I'd like to thank our neighbor Timothy Zastrow for taking some time to walk the three streets and give his assessment and recommendations. If not already announced, a second hearing will be scheduled to present the initial plans. And speaking of the extra effort...

A special thanks and recognition to The Shih family and Pastor Ben Slye and the Christian Life Center for coordinating another clothing drive and Thanksgiving dinner at The Alamo for those less fortunate. A great event each year, their compassion and decency towards their fellow men, women, and children is exemplary. Speaking of goodwill toward others....
