Town of Riverdale Park Appoints Police Chief

Mayor Vernon Archer announced the recent appointment of Teresa C. Chambers as Chief of the Riverdale Park Police Department. "I was very pleased to be able to nominate Teresa Chambers to be our new Police Chief," said Mayor Archer who administered the oath of office on Thursday, January 10, 2008. "I am excited about working with our new Chief. She brings a fantastic background that will help Riverdale Park see its police force move from the strong and respected force it already is to a municipal police force that will be second to none. She joins the rest of the Town government in commitment to making Riverdale Park a safe, clean, and beautiful place."

Town Administrator, Patrick J. Prangley, stated that "Chief Teresa C. Chambers is a nationally-recognized police executive who is well respected. Chief Chambers brings to our top-notched police department a vast experience in community-based law enforcement initiatives. We welcome her strong leadership and innovative solutions in law enforcement. We look forward to her contributions for the betterment of the Riverdale Park community."

Chief Chambers stated that "It is an honor to have been selected to work with the Town of Riverdale Park and its Police Department as the Chief of Police. This is a great community that places the highest of priorities on quality of life and safety for its residents, business community, and visitors; and I am excited about being a part of that commitment."

Chambers comes to the Town of Riverdale Park with nearly three decades of law enforcement experience. Following her retirement from an extensive career with the Prince George's County (Maryland) Police Department, Chief Chambers served as the Chief of Police for Durham, North Carolina, and then as Chief of the United States Park Police.

Chambers brings strong academic credentials to the job, having received a Bachelor's Degree in Law Enforcement / Criminology from the University of Maryland University College and a Master's Degree in Applied Behavioral Science with a Concentration in Community Development from The Johns Hopkins University. Code Corner Garbage, Refuse, and Trash

Chapter 36--Proper Vessel or Container

A container made of metal or plastic that has a tightly fitted lid that shall be no larger than 39 gallon capacity. **Residents must place garbage in a proper vessel or container with a tightly fitted lid for pick-up on scheduled pick-up days. Garbage placed to the curb in a plastic bag, or not in a correct container or vessel is a violation of Town Code and subject to the property owner receiving a municipal infraction violation with a penalty fine.

The Mayor's Report

Central Kenilworth Avenue Revitalization Project

Last fall I reported to you that the Town would be participating in the Central Kenilworth Avenue Revitalization Project in league with Maryland National Capital Area Park and Planning, and a wide variety of other stake holders in our region. It has become increasingly apparent that no group can solve the problems of the area by themselves, just as the problems are not the result of one single source.

There have been a number of meetings so far focusing on problems such as: traffic congestion; poor pedestrian safety; day-laborer congregation sites; loitering and public consumption of alcohol; deteriorating private buildings; litter; and crime. The State Highway Administration, Metropolitan Council of Governments, Washington Metropolitan Area Transit Authority (METRO), the County's Economic Development Corporation, County Police, and County Code Enforcement have all shown a real desire to cooperate with Riverdale Park and surrounding neighborhoods in addressing these problems in a comprehensive fashion.

Our objective for this project is to develop a group of agreements and commitments to do things like: 1) develop zoning guide lines that will bring social and commercial revitalization; 2) have safer and smoother traffic flow through the area; 3) provide for safer pedestrian traffic; 3) support reinvestment in both commercial and residential properties; 4) provide for increased cooperation between Town and county police and code enforcement; 5) better control loitering and disruptive/anti-social behavior along the corridor; and 6) a business association.

This project is slated to complete its review and present its findings and recommendations to Park and Planning—and ultimately are participating entities including Riverdale Park—by the end of this year. Organizers Jan Townsend of the Neighborhood Design Center and Dineen O'Conner of Park and Planning have done an outstanding job of keeping the effort moving forward and on schedule.

Resist Licensing of Drive Through Liquor at Kenilworth and Riverdale Road

One unfortunate threat to the revitalization of Kenilworth is a proposal to license a liquor store at the corner of Riverdale Road. Increasing the number of liquor stores anywhere along Kenilworth would not be good, but to put a drive through liquor store at that corner is particularly unacceptable. Such action would cause increased traffic congestion, spread the problems associated with loitering and public alcohol consumption, and generally impede the revitalization of that area that is showing real potential. It flies in the face of everything that the Central Kenilworth Revitalization effort is about.

The Town Council unanimously adopted a resolution to resist this proposed liquor store during a special legislative session in December and we are forging a broad and growing coalition to stop this liquor store from becoming a reality. I hope to get it reversed even before seeing it go before the liquor board, which is scheduled for 10:00 a.m. on February 22, 2008. However, if it should make it to a hearing, please come out and testify against this scheme. We will keep people informed via the Town Talk and Town Announce email lists as it progresses.

Noose Incident at Public Works

Most of you are aware that there was an incident at our Public Works Department last December that included the display of a hangman's noose that garnered attention in the local media. This incident is still under investigation and therefore I cannot discuss it in any detail. I can tell you that enforcing the law and maintaining a workplace that is free of harassment and discrimination is a top priority of my administration.

The Town Council also wanted to make sure that the matter was thoroughly and independently looked into. It therefore unanimously adopted a resolution asking that the Town's attorney investigate what actually happened and also review how Town management responded to the incident. While this action necessarily slowed the process, it will give us a result that we can have more confidence in. When the report is issued to the Town Council, it will probably have information that is not proper to reveal to the public. However, an overview will be made available that protects the privacy of our Town's employees.

Welcome to Police Chief Teresa Chambers

The Town has the good fortune of having been able to hire Teresa Chambers as its new Police Chief. Chambers retired from the Prince George's County Police Department after having worked her way up to command of District One, which Riverdale Park is part of. She then went on to be Chief of Police for the City of Durham, North Carolina, as well as having worked the National Capital Park Police. She is well known for her active and hands on leadership, and many of you will meet her over the coming weeks and months. Please welcome her and support her as residents always have our police officers.

Ward and Committee Reports

Ward One Report

I am pleased to join our mayor and fellow council members in welcoming Timothy Kimbrough to the town council representing Ward 5. It is good to have the whole town represented in our elected government.

In November, a resident alerted me that flooding is occurring in yards along Cleveland. Working with our public works staff, we were able to bring out the county to clear storm drains in the area. Unfortunately, the flooding is ultimately due to a blocked storm drain on CSX property. Getting a response from CSX has been a challenge. After several weeks of unresponsiveness from CSX, I contacted Senator Paul Pinsky's office to request assistance. Senator Pinsky and I have been in touch several times in the last two months, working toward solving the flooding issue. My hope is that with the senator's support, CSX can be forced to take responsibility for the problem and clear out the storm line. We will continue to keep on top of this it until the issue is resolved. At the town's repeated request, the gravel pile at the rail crossing has been removed.

According to our Town Administrator, CSX plans to install the four-quadrant gates to improve the safety of the rail crossing during the first quarter of this year. CSX stated that it will improve the grade of the crossing during the second quarter of this year. I'd like our town to be proactive about holding CSX to the schedule.

The title search needed to build the bike path from Town Center to College Park has been completed. The attorney hired to conduct the title search will be presenting his project report to the council, tentatively scheduled for the February legislative session. The Town's expenses for the title search will be reimbursed with support from M-NCPPC, thanks to the efforts of County Councilman Eric Olson. I will be monitoring the pace of progress closely in the coming months as the Town works with M-NCPPC to move this forward. The bike path is an economic development priority for our Town Center and is an amenity for residents that our Town should pursue with a sense of urgency.

Several potential tenants for the Town Center have approached the town this month. I don't know if they will "bite" or not, but we are doing everything we can to encourage them. A few quality tenants could generate greater foot traffic and make the entire Town Center more attractive to businesses.

I am pleased that we have a new police chief and I look forward to working with Chief Chambers to identify some of the specific public safety concerns we have in Ward 1. For instance, I know many residents remain concerned about the series of car thefts and break-ins that occurred during the summer.

Police Department

I also look forward to using Chief Chambers' experience to increase our utilization of county and state crime fighting resources.

M-UTC Committee

Last month I was appointed to the Riverdale Park Mixed-Use Town Center Design Review Committee by the Prince George's County Planning Board. Councilwoman Alice Ewen Walker and I will be the Town Council representatives to the committee for the 2008-2009 term. And I am proud to report that three other Ward Two residents will serve on the committee. Alan Thompson will provide technical expertise and act as the committee chair. Architects Marc Stauffer and Brian Boettger will use their professional experience to represent residents' interests. I believe that the M-UTC guidelines are an important tool for helping Riverdale Park shape our desired future. Thanks to Alan, Marc and Brian for dedicating their time and energy to this excellent committee.

Finance Committee Report Code Enforcement Software

The Town has budgeted to purchase software in FY 2007-08 to improve our efficiency on code enforcement issues. Software developer Jeff Hughes gave a presentation at the December Finance Committee meeting on software he has developed for code enforcement. Mr. Hughes is a past Vice President of the Code Enforcement and Zoning Officials Association. His software was selected by Town staff as the best value for the money during the competitive bid process earlier this year. Mr. Hughes will be preparing a revised cost estimate based on feedback from the meeting, and the committee is looking to move forward on obtaining software. **Capital Equipment Purchase**

The committee received a report from Town staff on our efforts to purchase four new police cruisers, one tractor, and an upgraded fuel pump system, as outlined in our FY 2007-08 budget. We are unable to use our planned lender, LaSalle Bank, due to a bank merger and change in loan terms. The staff has identified a new lender, Marquette Bank, with whom we have an established relationship. Marquette Bank has offered favorable loan terms that will save the Town nearly \$10,000 over the life of the loan. I brought the loan offer before the Council at the Special Legislative Meeting on December 17th, and the Council voted to approve the loan.

One such review this Committee will conduct is how this scenario unfolded: from the time the noose was placed to the final action of the Mayor and Town Administration. When completed it will be the responsibility of the Committee to present to the Council its recommendations.

Water, water everywhere revisited. At the last Public Works Committee meeting I asked Mr. Prangley about the completion of the storm water project off of Taylor Road. Having been resurrected in October of 2006, and seeing the Pumping Station completed, I have been assured and we are resolved to have this project completed this year. I thank all of you for your patience.

OK, now for the sales pitch; for those of you resolving to be more involved this year have I the venues for you. As always the Recreation Board is looking for volunteers who can lend a little time and effort to help make our Town events even more special. Now we're not asking for blood here just some help in throwing a few Town-wide parties. (You do like throwing parties, don't you?) Also the Community Affairs Committee is looking for resident input so as to help make Riverdale Park even better.

The Single Stream recycle containers are here and the word from most is enthusiastic approval. At the same time I've heard from some who are doing just fine without and prefer the yellow bins. For those wishing to forego the rolling container, please contact the Public Works Department directly or yours truly.

Going Green Save Energy, Save Money

Riverdale Park is a "Tree City" and has enjoyed this status for five years. Our trees should be a source of pride for the entire Town and they are a great resource that we should learn to use well. Many studies have shown that large shade trees can help keep our homes and gardens cooler in the summer. Of course, a scientific study shouldn't be necessary to understand this very simple effect. When Fall rolls around and the leaves start to pile up, we may see our trees as more of a nuisance. We may have trouble starting a cranky leaf blower that hasn't been used since last year or we may experience a ringing sensation in our ears after we use it for hours on end.

There is a better way! This is not magic, of course, but it is a very simple, low cost, energy efficient and money saving way to make the most of our tree resources. First of all, get rid of the leaf blower! These devices pollute the air with noxious exhaust and they generate noise levels that can lead to hearing loss. Get a simple lawn rake that does not produce unwanted noise, polluted gases or kick up clouds of dust.

Next, consider your entire lawn and garden area and look for a place where you can establish a compost pile for the leaves. By keeping the leaves that your trees shed, you can easily produce a rich, humus like mulch that is great for the trees, azaleas, rhododendron, hollies, yews and other acid loving plants. You will need to have an idea of how large the pile of leaves may be and mark the boundaries of what will be your compost pile. If you wish to contain the pile better you can use a roll of fencing material to just make a cylinder 4 or 5 feet in diameter. Then just scrape off the topsoil in the area where you want to compost. Save this topsoil because you will use it to pile on top of the leaves to keep them from blowing away and to "inoculate" them with the natural microorganisms from the soil.

Just rake the leaves into your pile and make alternating layers of leaves, followed by grass clippings or manure (great way to get rid of your doggy droppings) and a bit of the topsoil. If you have none of these materials you may wish to lightly fertilize with a nitrogen rich fertilizer. Wet the layers a bit as you pile them up. If made right, the pile will begin to "cook" within a week or two. If you dig into it you will note that it is actually steamy and warm. This is because the microorganisms are eating the leaves and other organic material and generating their own heat. During this period the heat generated actually disinfects the pile (can even kill roundworms from the doggy droppings). As the pile ages and cools down you will undoubtedly see earthworms start to move in. This is truly the sign of a healthy product that will be good for your plants. In fact many studies have shown that compost acts like a natural plant antibiotic to strengthen seedlings and mature plants alike.

There are only three things a compost pile needs to "cook". These are a good balance of carbon and nitrogen, the right moisture and good air flow. With a little practice you can find the right blend of materials, usually available right in your own garden, to make a great compost pile and produce your own healthy mulch material. Instead of spending money to have the Town take our leaves away and buying mulch to replace this resource, we can make our own! This will save energy by reducing the fuel spent by the trucks and our cars and save money for the Town and for our own pockets, all the while helping feed our great trees and gardens.
